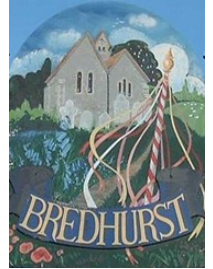


# **BREDHURST PARISH COUNCIL**
